



## **Terms and Conditions**

### **Shop and Ship Offer - For New Card Applicants**

#### **1. Introduction**

These offer terms and conditions shall be binding on you when you enter this offer.

#### **2. Offer for New Card Applicants**

**The offer of 'get up to US\$200 off on Aramex Shop and Ship (S&S) Shipping Charges' is available as follows:**

- (a) A discount of up to US\$15 on your shipping fees on your first two separate shipments. The discount will be applied after setting up your American Express Card on 'Auto-Pay' on the S&S website and following that, using your American Express Card online at S&S to pay your shipping fees on your first two separate shipments only, and
- (b) A reversal of up to US\$170 on your S&S shipping fees billed to your American Express Card statement when using your card online at S&S.

**Additionally, for New Card Applicants who are not existing members of S&S:**

US\$ 45 lifetime fee waiver on your S&S membership when signing up with S&S using the Promo Code that will be sent to you by AMEX (Middle East) B.S.C (c) ("AEME") via email within 30 days of issuing your Card.

#### **4. Spend Period**

#### **5. Offer Terms**

5.1. This offer is exclusively valid for:

- (a) Eligible individuals who are residents of the UAE and
- (b) Who do not or have not held a valid American Express card membership for the period of 6 calendar months preceding the offer start date, and
- (c) Who are also existing S&S members at the time of the offer start date.

5.2. This offer is exclusively valid for applicants who apply for The Dubai Duty Free American Express® Card, The American Express® Card, The American Express® Gold Credit Card, The American Express® Gold Card, The American Express® Platinum Credit Card or The Platinum Card® ("Eligible Card") by clicking the link in email communications, website banners, Facebook posts or other advertisements from AMEX (Middle East) B.S.C (c) ("AEME") or S&S and are



directed to the AEME website landing page related to this offer where they provide basic contact details in order to be contacted by an AEME representative for the Card application process.

- 5.3. This offer is exclusively valid for successful Card applications received by AEME between 10<sup>th</sup> November 2016 and 30<sup>th</sup> April 2017 and will only apply to the first Card issued to you.
- 5.4. Eligible Cardmembers must ensure the following upon successfully receiving their first Card in order to avail of the offer:
  - (a) Payment of the Annual Cardmembership Fee, and
  - (b) Activating the Card, and
  - (c) Obtaining an S&S membership (if not already a member) by signing-up for an S&S account using the offer Promo Code on their website [www.shopandship.com](http://www.shopandship.com), and
  - (d) Setting their eligible American Express Card as the default mode of payment, and
  - (e) Setting your Card on 'Auto Pay' under the 'Shipping Payment Option' section on the S&S website, and
  - (f) Incurring their S&S shipping costs on the Eligible Card, and
  - (g) Maintaining a Card account that is shown as active and regular during the Spending Period and at the time the shipping fee reversal credit is awarded. For the avoidance of doubt, any cancelled or deactivated accounts before or on 31<sup>st</sup> July 2017 will not be eligible for the offer.

## **6. Awarding the Offer**

- 6.1. Applicants that are approved by AEME in accordance with the offer terms will be awarded a reversal on their shipping fees for purchases made during the designated spending periods using their Eligible Card at the S&S website.
- 6.2. The applicable amount of the S&S shipping fees that will be reversed will vary based on your approved American Express Card product.
- 6.3. The offer amount can be availed in 2 parts.
- 6.4. The first part of the offer as per 2 (a) can be availed directly at the S&S website.
  - 6.4.1. The discount will be available only on the S&S shipping costs on your first two separate shipments done online on the S&S website during the Offer Period using your Eligible Card, up to a value of US\$15 of your shipping fees against each shipment.
  - 6.4.2. This discount will be applied by S&S, at the time of check out on the S&S website and will not appear on your Statement of Account.
  - 6.4.3. If the amount of your S&S shipping fees on a shipment is lower than US\$15, the balance value of the discount cannot be carried forward to your next S&S shipping fees. For example, if you incur shipping fees of US\$10 on your purchase, the balance US\$5 of your US\$15 discount will not be available to you as a discount on your next shipment.
  - 6.4.4. If you make have a shipment that incurs shipping fees higher than US\$15, then the US\$15 offer will be applied as a discount on your shipping fees at the time of checkout and the balance value of the shipping fees transaction will be billed to your Eligible Card Account. For example, if you incur shipping fees of US\$20, S&S will apply the offer at the time of checkout and only US\$5 will be billed to your eligible Card account.
