



## **Terms and Conditions**

### **Shop and Ship Offer – Existing Cardmembers**

#### **1. Introduction**

These offer terms and conditions shall be binding on you when you enter this offer.

#### **2. Offer**

**For existing Cardmembers who are existing members of Aramex Shop and Ship (S&S):**

#### **5. Offer Terms**

5.1. This offer is exclusively valid for:

- (a) Eligible individuals who are residents of Bahrain, Kuwait, Qatar, Jordan, Oman, or Lebanon and
- (b) who are American Express Cardmembers and hold any basic American Express Personal Cards ("Eligible Card") from AMEX (Middle East) B.S.C (c) ("AEME")
- (c) Who are also existing S&S members, or become S&S members during the offer period.

5.2. This offer is not valid for individuals holding American Express Corporate Card products only.

5.3. Eligible Cardmembers must ensure the following in order to avail of the offer:

- (a) Obtaining an S&S membership (if not already a member).
- (b) Setting their eligible American Express Card as the default mode of payment, and
- (c) Setting their Card on 'Auto Pay' under the 'Shipping Payment Option' section on the S&S website, and
- (d) Incurring their S&S shipping costs on the Eligible Card.

- 6.2. This one-time discount offer, up to a value of \$15 of your shipping fees will be applied by S&S, at the time of check out on the S&S website.
- 6.3. If the S&S shipping charges transaction amount is lower than the offer amount, the balance value of the maximum discount cannot be carried forward to the next S&S shipping fees transaction.

If you make a purchase that incurs shipping charges higher than US\$15, then the US\$15 offer will be applied as a discount on your shipping fees at the time of checkout and the balance value of the shipping fees transaction will be billed to your eligible card account.
